Debarment Application Form

The Public Procurement Commission (PPC) is pleased to inform members of the public, procuring entities, and interested stakeholders that a Debarment Application Form is now available on the Commission's official website: www.ppc.org.gy. This Form (also attached to this Circular as Appendix A) has been developed to assist individuals and entities in making formal applications for Debarment, pursuant to the applicable legal framework.

What is Debarment? It is a sanction imposed on a supplier or contractor that restricts their participation in public procurement for a specified period. This action may be taken on any of the grounds set out in Regulation 3 of the Procurement (Suspension and Debarment) Regulations 2019 such as breach of a public procurement contract, supplying false information in the submission of a bid, default on tax obligations and or committed acts of collusion and coercion.

Under Regulation 5 of the aforementioned Regulations, made pursuant to the Procurement Act, Cap. 73:05, the PPC is required to maintain a public register of all suspended or debarred suppliers and contractors. This register is updated and accessible on the Commission's website.

The law empowers procuring entities or any other person to submit an application (termed 'a proposal') to the PPC for the debarment of any supplier and or contractor.

The Debarment Application Form is intended to streamline the process by which stakeholders can submit relevant information to the PPC when seeking the debarment of a supplier or contractor. Persons or entities in possession of evidence or information that may justify such an application are encouraged to make use of this resource.

The Commission invites all stakeholders to utilise this form where appropriate and to uphold the principles of transparency, accountability, and integrity in the public procurement process.
