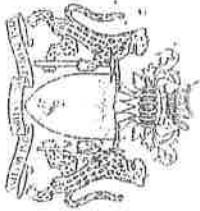

Please be informed that part of the documents submitted within the tender for the above procurement, the following were observed.

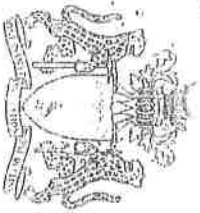
1. Bid security in the form of insurance and not Bank Guarantee were proven by T#1, T#2 and T#5.
2. ISO/WHO approval for pharmaceutical procurement was not submitted for T#4.
3. The warranty/guarantee for T#1 was not supplied.
4. Some discrepancies exist regarding T#3 where proof of financial capacity stated at G\$10M while the bid provided was in excess of G\$27SM. There was also another document indicating bid security for G\$800M.

With these observations, I decline to sign off on the evaluation of this tender.
